OFFICIAL RULES

SWEEPSTAKES DESCRIPTION: The Nittany MinitMart 2023 ATV Giveaway (the "Sweepstakes") consists of a random draw sweepstakes. The Sweepstakes starts on August 30, 2023 at 12:00:00 AM Eastern Time and ends on November 21, 2023 at 11:59:59 AM Eastern Time (the "Sweepstakes Period"). The Sweepstakes provides entrants with sweepstakes entries for the opportunity to win the prize set forth below. By participating, you unconditionally accept and agree to comply with and abide by these Official Rules and the decisions of Nittany Oil Company, Inc. ("Sponsor") which shall be final and binding in all respects.

ELIGIBILITY: The Sweepstakes is open only to legal residents of Pennsylvania who are at least age 21 at the time of entry and have a valid, registered Nittany MinitRewards® Card account with a valid email address linked to the account (the "Participants"). To open a free, Nittany MinitRewards® Card account, visit any Nittany MinitMart location and ask to join. You must then go to <https://nittanyminirewards.myquestaccount.com/guest/> to link a valid email address to the Nittany MinitRewards® Card account. Employees of Sponsor and of its affiliates, subsidiaries, advertising and promotion agencies and their immediate family members and/or those living in the same household of each are not eligible to participate. Void where prohibited. Subject to all applicable federal, state, and local laws and regulations.

TO ENTER: Participants can receive a total maximum of two (2) entry per day with a maximum total of one hundred sixty eight (168) entries by the close of the Sweepstakes Period regardless of which entry method used as provided below.

- Maximum of four (4) entries within August
- Maximum of sixty (60) entries within September
- Maximum of sixty two (62) entries within October
- Maximum of forty two (42) entries within November

Obtain entries as follows:

1. Method One: 1. One (1) entry will be provided for visiting a Nittany MinitMart convenience store and purchasing any prepared on site Food Service item and/or Monthly Featured Product (define below) with a transaction total of at least Five \$5.00 Dollars pre-tax in a single transaction using and scanning a valid, rewards card. Alcohol and other age-restricted items are not considered qualifying purchases.

2. Method Two: Entries may be received without a purchase, by mailing a 3"x5" index card with your name, age, postal address, email address, telephone number, your Nittany MinitRewards® card or membership number and the location of your local Nittany MinitMart, in an envelope to "**Nittany MinitMart Giveaway Entry, 1540 Martin St, State College, PA 16803, Attn: Marketing.**" Entries must be postmarked or received no later than November 22, 2023. Entries shall become the property of Sponsor and shall not be acknowledged or returned. Each entry must be an original (no photocopies or other reproductions) and mailed in a separate envelope, bearing sufficient postage. You can submit one (1) entry card each day; and there is a limit of one (1) entry card per envelope.

ENTRY GUIDELINES: An entry will not be eligible to win if the Nittany MinitRewards® Card account to which the entry is linked does not have a valid email address. To ensure that you have registered a valid email address, review your profile at nittanyminimart.com. Multiple Participants are not permitted to share the same email address. Any attempt by any Participant, to obtain entries by using multiple/different email addresses, identities, or any other methods will void that Participant's excess entries and Participant may be disqualified at the discretion of the Sponsor. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email address used that is linked to the registered Nittany MinitRewards® Card account will be deemed to be the Participant. The "authorized account holder" is the natural person assigned an email address by an internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Eligibility determinations are subject to Sponsor's sole discretion. Potential winner may be required to show proof of being the authorized account holder.

WINNER VERIFICATION AND NOTIFICATION: A Participant who is randomly selected as the potential winner (a "Potential Winner") will not be awarded any prize, even after being notified as Potential Winner, unless and until the Potential Winner's eligibility has been verified. Potential Winner will be notified via email and/or telephone. If the Potential Winner is deemed ineligible or does not respond in a timely manner, an alternate winner may be selected and notified. The Potential Winner will be announced through Nittany MinitMart web site and social media pages on December 8, 2023. A Potential Winner must complete and submit all necessary paperwork, such as a verification of eligibility and identity or any liability or publicity release, within 5 days the date of notification in order to be certified as the winner of the Sweepstakes drawing. If a Potential Winner fails to respond to any notification attempt or return verification documents within the time period specified by Sponsor, or if any attempted notification is returned as undeliverable, or an undeliverable or other error message is received by Sponsor from the Potential Winner's internet service provider—even if sent by the internet service provider in error and even if the notice is actually received thereafter, the Potential Winner will be disqualified and forfeit the Prize (defined below). PRIZE: The winner will receive a 2023 Polaris Sportsman ATV (the "Prize") with an approximate retail value of Six Thousand Nine Hundred Ninety Nine (\$6,999) Dollars.
